iMINCO is a leading online mining information platform offering industry specific information and guidance for people working, or wanting a career, in the mining industry. GO2 Skills & Training is a nationally Registered Training Organisation (RTO 40927), delivering accredited and non-accredited workplace training and education courses with a current focus on the mining and construction sectors. The MOU follows the successful completion of a trial program between both parties, in which 70 + students were onboarded into GO2 S&T online courses through the



iMINCO platform. Students who enrolled in the courses and successfully completed them, were assessed by GO2 S&T trainers and Statements of Attainment were issued.

GO2 S&T has launched its first online training course for the mining sector and has another 2 courses currently under development. Under the MOU, iMINCO will provide expert digital sales and marketing services to assist with the growth of GO2's online mining course and increase its digital presence. GO2 S&T will be Registered Training Organisation and manage course content, course delivery, compliance, and issuance of certificates.

The Company is initially targeting a minimum of 20 students per week and has the capacity to deliver the online training to 50 + students per week with its current resources. GO2 S&T will aim to steadily increase the number of students undertaking online studies over in the coming months. The average course cost is expected to be \$600 which is paid in full by students prior to enrolment with access being granted to the online training portal only once a student has paid the course fees. iMINCO will be paid a 25% fee of the course cost for every student delivered through their digital platform.

In addition to the MOU, GO2 will utilise its extensive client and candidate database to drive additional sales of its online training courses. In the short term, the Company will target all active mining clients across both its recruitment and training divisions.

The MOU reiterates the Company's commitment to enhance its online training capability and to meet the demands of Australian industry and its workforce. In addition, the Company will continue to assist in the ongoing re-training and re-deployment of the national workforce.

Director Paul Goldfinch: "We are very pleased to have launched our first online training course and we are thrilled to have partnered with iMINCO. We have always had a strong relationship with them and the opportunity to collaborate with them and leverage their expertise in the digital field is something we're very excited about. Our push into online training is in line with our overall intent to focus on quality high margin business opportunities for the group."
